Hello Joseph

Thank you for consulting Gloucestershire County Council (GCC) on this matter. I have the following officer comments to make.

#### **Ecology (Biodiversity)**

We note that HRA AA (Stage 2) was triggered by the current content of the Neighbourhood Plan because it allocates some development which may have likely significant effects on 'European' Sites. The main concern being additional in-combination recreational effects upon sensitive designated sites. The potential for changed water quantity, level and flow are also considered. An HRA report covering AA (Stage 2) has been compiled and we see that Natural England have agreed to the report's conclusions, i.e., there would be no adverse effects upon the integrity of any 'European' Site. On reading the HRA report we have no reasons to doubt its conclusions.

The SA Report concludes the Neighbourhood Plan could tentatively have minor positive effects on biodiversity in the long-term. A mandatory requirement for biodiversity net gain of at least 10% that is being introduced in November 2023 is likely to strengthen this conclusion.

The plan sets out a desire to enhance biodiversity within the parish and to safeguard ecological systems and features. This aligns with county and government objectives including measures in the Environment Act 2021. Since last commenting on the Neighbourhood Plan its vision, objectives and policies gives better support for the conservation and enhancement of local biodiversity. Such policy cover is not absolutely essential, although useful, as the District, Waste and Mineral Local Plans cover such matters well.

## **Transport Planning Comments**

The draft Fairford Neighbourhood Development Plan (NDP) shows comprehensive consideration of the issues affecting the town, including transport. Transport is integrated throughout the document and its appendices.

It may be helpful to refer to the Gloucestershire Local Transport Plan see <u>LTP</u> in terms of providing the context for connectivity and movement here. The LTP considers Fairford in the South Cotswolds Connecting Places Strategy within the LTP. To this is added the treatment of different transport modes. For example, walking and cycling are mentioned briefly in the NDP, whereas the over-arching Cycling and Walking Infrastructure Plan proposes to bring the strategic walking and cycling network to Fairford, and supports the linking of the town to settlements such as Lechlade for walk and cycle commuting and leisure purposes.

The NDP also refers to the public transport provision – rail and bus – recognising the poor and declining bus provision in the face of an aging population. There may be a need to seek innovative ways of supporting public bus services and community transport if Fairford is to meet its residents transport needs across the plan period. Is there scope for the NDP to consider this along with general measures to enhance connectivity?

Fairford Town Council has prepared a Neighbourhood Development Plan covering the whole of its parish area. The Plan sets out a vision for the future and planning policies which will be used to determine planning applications locally. 3.3. The Neighbourhood Plan must also be able to show that its policies are in general conformity with <u>all other relevant</u> the strategic policies of the development plan, <u>including those</u> which currently comprises policies or saved policies of the Cotswold District Local Plan 2011-2031, of the Gloucestershire Minerals Local Plan 1997 — 2006 Minerals Local Plan for Gloucestershire 2018-2032; and of the Gloucestershire Waste Core Strategy 2012 — 2027; and the ten saved policies from the Gloucestershire Waste Local Plan 2002-2012. The second document is in the process of being replaced, it passed the pre-submission consultation stage and is expected to be adopted within the next year. The Waste Core Strategy and Waste Local Plan are both due to be replaced in the coming years by a consolidated Waste Local Plan for Gloucestershire.
