1. Declarations of Interest

2. Neighbourhood Planning: Regulation 18 Decision on the Fairford Neighbourhood Development Plan

The purpose of bringing this decision to the Cabinet Member was to consider whether the Fairford Neighbourhood Plan, as modified, meets the Basic Conditions required by the Localism Act, and therefore proceeds to a referendum on 4th May 2023.

The officer began by providing a summary of the report and its recommendations to the Cabinet Member.

The officer noted that the report at Annex A was balanced and had taken into account representations put forward.

The Cabinet Member noted that we hadn't received any comments on the item.

The Cabinet Member noted that there had been many discussions on the neighbourhood plan.

The Cabinet Member was grateful to be invited to a meeting in Stow with officers of the Council on the plan which was highlighted as a complex piece of work.
